IV.Graduation Requirements

1. 「論文指導(一)(二)」6學分及教育學分皆不計入畢業學分；凡註冊後應至少修習一門科目(含論文)，否則應辦理休學。已修畢最低畢業學分而論文尚在撰寫中者，次學年起每學期必須選修「論文」。
2. 必修課程，共計16學分(不含論文指導(一)、(二)6學分)，選修至少30學分(本所之選修最低應選27學分)。
3. 研究生畢業須符合本系「英語能力」之基本要求。詳細內容請見本系「學生英語能力畢業門檻辦法」。
4. 新生入學後視其大學部修課內容決定是否必須補修會計系大學部審計學6學分與中級會計學6學分。
5. 研究生應於申請學位考試前修習通過於「台灣學術倫理教育資源中心(<https://ethics.nctu.edu.tw/>) 網路教學平台之「學術研究倫理教育」課程。
6. 畢業總學分數之遠距教學課程學分數，不得超過畢業總學分數之二分之一。

1. "Thesis Advice I and II" for 6 credits and education credits are not counted towards graduation credits. Students must enroll in at least one course (including thesis) after registration; otherwise, they must apply for suspension. Those who have completed the minimum graduation credits but are still working on their thesis must enroll in "Thesis Advice" every semester from the next academic year.
2. Minimum graduation credits: 46 credits, including 16 credits of Required courses (excluding 6 credits for Thesis Advice I and II), and at least 30 credits of elective courses (Electives within this department must comprise at least 27 credits).
3. Students must meet the department's basic requirements for "English proficiency". For details, see the department's "English Proficiency Graduation Requirement Policy."
4. After enrollment, whether new students must make up for 6 credits in Auditing and 6 credits in Intermediate Accounting from the undergraduate program will be determined based on the content of their undergraduate coursework.
5. Students should complete and pass the "Academic Research Ethics Education" on-line course on the Center for Taiwan Academic Research Ethics Education (<https://ethics.moe.edu.tw>) before applying for their degree examination.
6. The number of credits earned through distance education courses must not exceed half of the total credits required for graduation.
